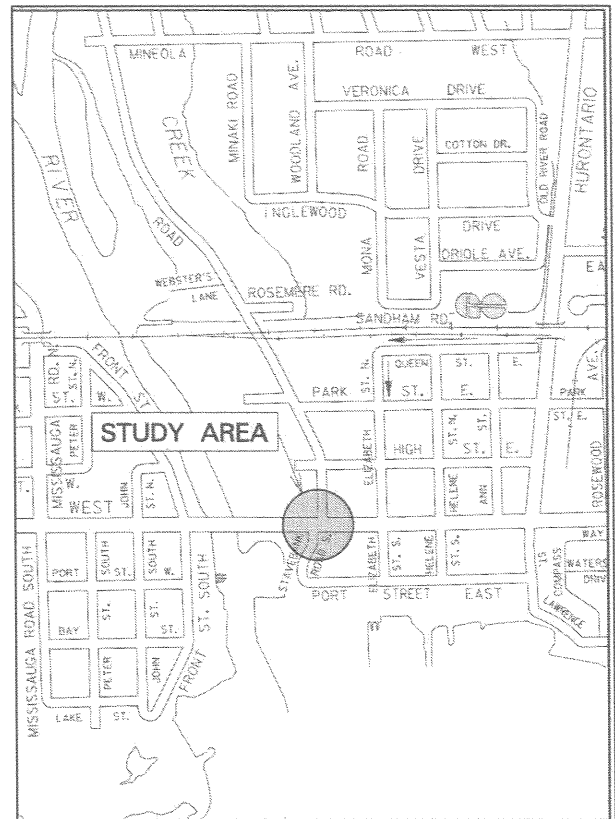

The City of Mississauga is undertaking a study to investigate a wide range of alternatives for intersection geometric improvements to further enhance the efficiency and safety of the intersection of Stavebank Road and Lakeshore Road East. The main purpose of the study is to determine the preferred improvement plan for the intersection of Stavebank Road and Lakeshore Road East, while addressing the concerns and issues of affected stakeholders, technical agencies and the general public. The location of the proposed intersection improvement is shown on the adjacent plan.

The study is being conducted in compliance with Schedule "B" of the Municipal Engineers Association "Municipal Class Environmental Assessment (October 2000, as amended in 2007)", which is approved under the Ontario Environmental Assessment Act.

A key component of the study will be consultation with interested stakeholders (public and regulatory agencies). A Public Information Centre (PIC) has been arranged to provide interested parties with an opportunity to review and discuss issues related to the project. The PIC is to be held as follows:

Anyone with an interest in the study is invited to attend and participate. Upon completion of the study, a project file will be prepared for public review and comment. The Notice of Study Completion will be issued for a 30 day review period. Subject to comments received, and receipt of necessary approvals, the City intends to proceed with the planning, design, and construction of this project.
