#### WHAT?

The City of Mississauga is undertaking an Individual Environmental Assessment (EA) under the *Environmental Assessment Act* for the 1 Port Street East Proposed Marina Project.

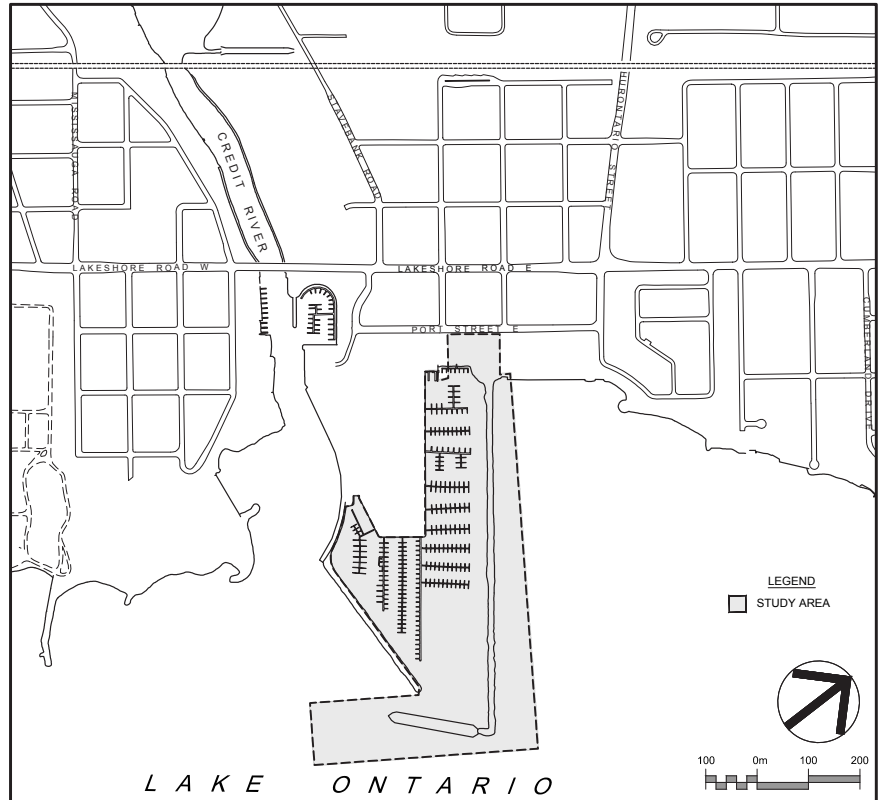
The City of Mississauga prepared a Terms of Reference for the 1 Port Street East Proposed Marina Project EA. The Terms of Reference sets out the City's work plan for addressing the *Environmental Assessment Act* requirements in the Individual EA. This Terms of Reference builds upon all of the background work completed to date, includes alternatives that will be considered in the EA, the public consultation activities and addressing comments raised during the review of the draft Terms of Reference. If approved by the Minister of Environment, Conservation and Parks, the Terms of Reference will provide the framework for the preparation of the Individual EA.
